What to know about the Supreme Court's midnight Alien Enemies Act order

The CNN article discusses the U.S. Supreme Court's temporary halt on the Trump administration's deportation of Venezuelan migrants under the 1798 Alien Enemies Act. The administration aimed to deport individuals alleged to be members of the Tren de Aragua gang without adequate notice or legal recourse. Responding to an emergency appeal by the ACLU, the Court's unsigned order prevents further deportations until due process is ensured. This decision reflects growing judicial concern over the administration's adherence to legal standards and underscores tensions between executive actions and constitutional protections in immigration enforcement.

Ukraine says Russian attacks continuing despite Putin's 'Easter truce'

The article from BBC reports that both Russia and Ukraine have accused each other of violating a 30-hour Easter ceasefire unilaterally declared by Russian President Vladimir Putin. Ukrainian President Volodymyr Zelensky stated that between Saturday evening and Sunday morning, Russian forces conducted 387 shelling incidents, 290 drone operations, and 19 offensive actions. Conversely, Russian-installed officials in occupied Ukrainian territories claimed Ukrainian forces shelled areas like Kherson and Donetsk. Zelensky emphasized that Ukraine would mirror Russia's actions, advocating for "silence in return for silence." The truce is viewed by some as a strategic move by Moscow to bolster its diplomatic standing and facilitate troop rotations at the front lines.

DHL to suspend global shipments of over \$800 to US consumers

DHL Express will temporarily suspend global business-to-consumer shipments valued over \$800 to the U.S. starting April 21 due to new U.S. customs rules. The change, effective April 5, lowers the threshold for formal customs entry from \$2,500 to \$800, requiring more documentation and processing. While business-to-business shipments will still be accepted, delays are expected. Shipments under \$800 remain unaffected. DHL stated the pause is temporary and aims to help customers adjust to the new regulations, which may change again by May 2. The move follows Hongkong Post's similar action amid growing tensions over revised U.S. import policies targeting China and Hong Kong.
