



Zelensky's visit to Saudi Arabia ahead of critical U.S. talks highlights Ukraine's urgent need to secure diplomatic and military backing as Washington reconsiders its approach. With the U.S. engaging directly with Zelenskiy heads to Saudi Moscow and pausing military aid to Kyiv, Ukraine faces increasing pressure Arabia ahead of crunch to explore alternative alliances and negotiation channels. If the talks yield positive outcomes, they could pave the way for ceasefire discussions and renewed international support. However, if Ukraine fails to gain assurances, it risks further isolation, leaving it vulnerable to prolonged conflict and shifting geopolitical dynamics that may not favor its position.



Duterte's readiness to accept arrest if the ICC issues a warrant reflects his defiance amid ongoing drug war investigations. Despite withdrawing from the ICC, it retains jurisdiction over past crimes. His actions, including supporting candidates in Hong Kong, suggest a strategic move to strengthen his political influence. The Philippine government's possible compliance with an arrest warrant highlights complexities in international law and sovereignty, with implications for domestic politics and global relations. Duterte's stance could further complicate the Philippines' relationship with international legal bodies, potentially straining its diplomatic ties and influencing its internal political landscape.
