US Marines arrive in LA; California governor warns 'democracy under assault'

Under President Trump's directive, the deployment of 700 Marines and over 2,000 National Guard troops to Los Angeles in response to anti-ICE protests marks a critical escalation in federal intervention in domestic unrest. While framed as a law-and-order move, the action has triggered constitutional concerns, strained federal-state relations, and fueled broader nationwide demonstrations. If the militarized response continues, it is likely to intensify polarization, provoke legal challenges over executive authority, and elevate the crisis into a defining issue for the 2025 U.S. election cycle—shaping both domestic policy debates and international perceptions of American democratic stability.



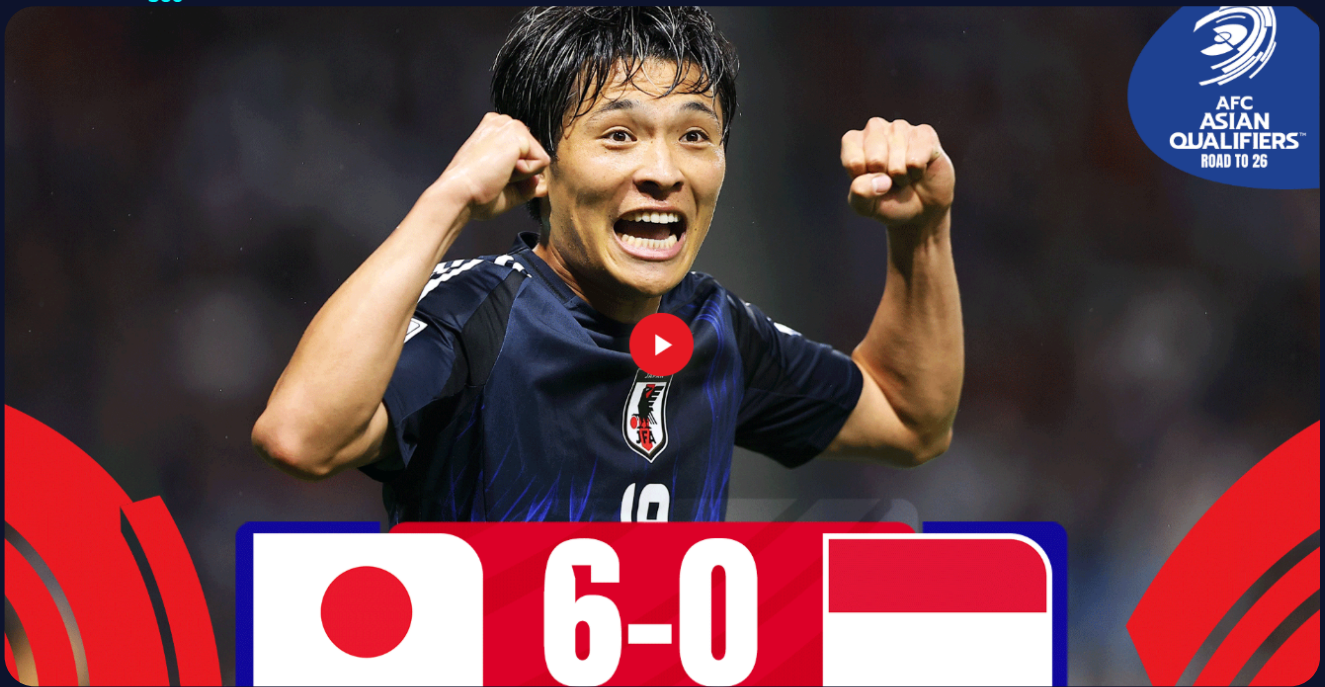
US, China reach deal to ease export curbs, keep tariff truce alive

The U.S. and China reached a preliminary agreement in London to ease export controls—particularly on rare earth minerals—and maintain the existing tariff truce. While markets reacted cautiously, the deal signals renewed commitment to stabilizing trade ties, with both sides considering limited rollbacks on semiconductor and aviation restrictions. If ratified in the coming weeks, the agreement could reduce supply chain tensions, though unresolved structural issues may still pose risks to long-term economic normalization.



Egypt's crackdown drives Sudanese refugees on new route to Libya and beyond

Egypt's intensified crackdown on undocumented Sudanese refugees has forced thousands to abandon hopes of regional asylum and turn instead to dangerous migration routes through Libya toward Europe. This shift follows restrictive new asylum policies and increased detentions within Egypt, effectively closing a major refuge for those fleeing Sudan's civil war. Looking ahead, this rerouting is likely to increase irregular migration flows into Europe, strain Libya's already fragile transit infrastructure, and trigger greater EU pressure on North African governments to enforce border controls—while raising broader humanitarian and legal challenges around refugee protection and regional responsibility-sharing.
