The U.S. and China have reached a framework agreement to keep TikTok running in the United States by spinning off its U.S. operations into a new company dominated by U.S. investors (about 80% ownership), while ByteDance retains a minority stake (~19.9%). The deadline for compliance has been extended until December 16 to allow completion of the transaction. Key security measures include U.S. control over user data, though some Chinese-linked features like the algorithm are expected to be licensed rather than fully severed. The deal eases tensions and avoids an outright ban, though residual Chinese influence and licensing terms could remain contentious.



Peru researchers unveil 10-million-year-old dolphin-like fossil found in desert

A team of Peruvian paleontologists uncovered a fossilized skeleton of a small marine mammal, similar to a dolphin or porpoise, dated between 8 and 12 million years old, in the Ocucaje Desert south of Lima—a region that was once part of the Pacific Ocean. The site, shielded by coastal mountains, provided calm waters allowing marine species to thrive. This find enriches knowledge of Peru's ancient marine biodiversity and coastline evolution. Assessment: it's a significant addition that sheds light on marine ecology of the past, but further research is required to clarify behavioral ecology and environmental changes impacting its survival.



Cuba calls on United Nations to stop U.S. militarization of the region

Cuban Foreign Minister Bruno Rodriguez urged the United Nations and Security Council to act against what he called “dangerous militarization” by the United States in the Caribbean, citing operations under the guise of anti-drug efforts that destroyed Venezuelan boats, killed civilians, and intercepted fishing vessels. He argued Washington uses narcotics as a pretext while serving as a hub for organized crime money laundering. The appeal coincides with Cuba's annual campaign to lift the U.S. embargo, highlighting rising tensions but facing uncertain international backing. ([reuters.com](https://www.reuters.com))
