👉 Ontario to stop running anti-tariff advert that angered Trump

Ontario Premier Doug Ford said he will pause the province's anti-tariff ad campaign in the U.S. after it prompted President Donald Trump to end trade talks. Ford announced the suspension following a call with Prime Minister Mark Carney, saying the ad will stop airing Monday to allow talks to resume. The commercial, quoting former U.S. President Ronald Reagan criticizing tariffs, drew Trump's ire, who labeled it "FAKE" and "egregious." The Reagan Foundation also objected, saying the Ontario government used Reagan's words selectively and without permission. Carney said Canada is ready to resume negotiations "when the Americans are ready."

👉 Venezuela's Maduro says US 'fabricating war' as it deploys world's largest warship

Venezuelan President Nicolás Maduro accused the United States of "fabricating a new war" after it deployed the USS Gerald R. Ford, the world's largest aircraft carrier, to the Caribbean — a major escalation of U.S. military presence in the region. Washington says the move targets drug trafficking, but analysts believe it signals an attempt at regime change. U.S. President Donald Trump has accused Maduro of leading a drug cartel, a claim he denies. The U.S. has carried out 10 airstrikes on vessels in the Caribbean, while Maduro warned that Washington seeks an "eternal war," amid growing debate over the legality of U.S. actions.

👉 Suspected drug kingpin caught after audacious escape from house arrest

Chinese drug lord Zhi Dong Zhang, known as Brother Wang, has been extradited to the US after a dramatic escape attempt. Cuba first handed him over to Mexico, which then transferred him to US custody on drug trafficking and money laundering charges. Zhang is accused of running a vast fentanyl and money-laundering network linking Chinese suppliers and Mexican cartels, including Sinaloa and CJNG. Former DEA officials describe him as a key broker between chemical firms and cartels, converting proceeds into cryptocurrency. After escaping house arrest in Mexico by breaking through a wall and fleeing by jet to Cuba, Zhang was recaptured and deported.
