Trump withdraws US from key climate treaty and dozens of other groups

US President Donald Trump has announced the withdrawal of the United States from dozens of international organisations, including key bodies involved in combating climate change such as the UN Framework Convention on Climate Change and the Intergovernmental Panel on Climate Change. The White House said the organisations no longer serve US interests and promote globalist and ideological agendas. The decision also affects non-UN groups working on clean energy, democracy and international security. European leaders criticised the move, warning it would weaken global cooperation, while critics in the US said it undermines science and international efforts to address global challenges.

Vance criticises Denmark and Europe's handling of 'critical' Greenland

US Vice President JD Vance said Greenland is “critical” for US and global defense against potential Russian or Chinese missile attacks, criticizing Europe and Denmark for underinvesting in its defenses. The White House said it is considering a possible purchase of the semi-autonomous Danish territory, while military action to annex it had also been suggested. Denmark warned this could threaten NATO and emphasized that Greenland is not for sale. Strategically located between North America and the Arctic, Greenland hosts the Pituffik Space Base, vital for early missile detection and monitoring maritime activity in the region.

Oligarch linked to bribery paid Andrew £15m for mansion

Andrew Mountbatten-Windsor received millions from Kazakh oligarch Timur Kulibayev, who used a loan from Enviro Pacific Investments—linked to a 2007 bribery scheme—to buy the former prince’s Berkshire mansion, Sunninghill Park, for £15m. Kulibayev, son-in-law of Kazakhstan’s then-president, denies wrongdoing and says the funds were legitimate. Experts say the deal had “blatant red flags” that warranted checks to avoid laundering corrupt proceeds. Kulibayev reportedly paid £3m above the asking price and £7m over market value. Questions remain over whether Andrew conducted the proper legal due diligence. He did not comment on the transaction.
